ABOUT

Nathan Crane is a Utah criminal defense lawyer who primarily represents individuals and companies accused of criminal activity anywhere in the country. Nathan aggressively represents adult and juvenile clients, responding to search warrants, government investigative demands, summonses, service of subpoenas, and in trial.

On matters involving cryptocurrency blockchain, Nathan has the experience and knowledge needed to support your legal rights. He has also represented student-athletes on variance, transfers, and eligibility issues. He has presented before local school boards to address UHSAA denials and assisted in guiding parents through the complicated process from start to finish.

Before private practice, Nathan served as an Assistant U.S. Attorney in the District of Nevada and a Deputy District Attorney in Clark County, Nevada, where he prosecuted more than 1,000 felony cases (including white collar, fraud, sex crimes, and violent crime). This experience has given Nathan an exceptional perspective in defending his clients.

A unique area of Nathan's practice involves representing Utah and Nevada residential treatment facilities, including assisted living and hospice care centers. This work includes conducting internal investigations, assisting the centers' leadership and staff on how best to manage difficult residents, and determining when to involve local law enforcement (and then coordinate involving them). He also assists the centers in responding to subpoenas and, when needed, serves as a media spokesperson for all media inquiries relating to investigations and accusations.

Nathan appears regularly in court and has conducted multiple felony jury trials and numerous misdemeanor trials. He has handled cases and appeared in courtrooms across the country, including Utah, Arizona, California, Florida, Idaho, Nevada, New Hampshire, New York, Oklahoma, Pennsylvania, Virginia, and Washington, D.C.

Nathan has also argued criminal appeals before the Nevada Supreme Court and the Tenth Circuit Court of Appeals. He also applies his wide-ranging courtroom experience to the firm's SnowTrial Consulting work. He is a Federal Criminal Justice Act Panel member and is often appointed to defend indigent defendants in federal criminal court. He is a member of the American Society of Trial Consultants. Nathan has been a legal commentator on KSL Radio's "The Night Side Project."
