His family law practice often involves custody disputes that encompass religious beliefs. He also uses his business finance background to advise clients in the area of divorce, especially in situations involving division of significant marital estates and business assets.

Rodney is experienced in all aspects of litigation – including discovery, motion practice, evidentiary hearings, trial, and appeal. He has litigated cases involving a wide range of general and business disputes, including products liability, professional liability, employment, ERISA, and patent disputes. He offers broad experience in computerized litigation support.

Before joining the firm, Rodney served as Associate Deputy Attorney General on the immediate staff of the Deputy Attorney General of the United States in Washington, D.C. In that position, he exercised the DAG's oversight function for the Lands and Natural Resources Division and the Civil Division.
