REPRESENTATIVE MATTERS

- Defended county in consolidated appeals before the Utah State Tax Commission and succeeded in having all
 appeals denied, thus preserving tens of millions of dollars in tax revenue.
- Obtained favorable decisions from UALD and EEOC in proceedings against employer in case where employee was accused of rampant sexual harassment, discrimination, and retaliation.
