## REPRESENTATIVE MATTERS

- Berger v. Greenberg, et al.– Utah Second District Court/Utah Court of Appeals. Alleged Medical Negligence related to robotic lung surgery. After four years of litigation, I obtained summary judgment in the District Court related to the standard of care. Successfully briefed and argued the matter before the Utah Court of Appeals, which upheld the District Court's dismissal.
- The State of Utah v. Merck & Co., Inc. Utah Third District Court. Represented Merck in lawsuit by the State of Utah related to painkillers associated with an increased risk of heart attack and stroke. Case involved alleged damages in the tens of millions of dollars. Case concluded in settlement.
- Favero v. Werner Transportation Utah Third District Court. Part of litigation and trial team representing a Plaintiff who was catastrophically injured in collision by a semi-truck. After lengthy trial, we obtained a multi-million dollar jury verdict for Plaintiff.
- HIPAA Breach and Investigation Health and Human Services/Office for Civil Rights Investigation. Successfully, represented health care provider in multi-year HIPAA investigation related to the breach of medical records of several hundred thousand patients. Investigation concluded with no fine or monetary penalty imposed.
